Note: The owner/operator provided supplemental resources requirement is a Contingency Plan approval approach for non-profit umbrella contingency plans under Washington law and regulations that allow a WSMC member to supplement WSMC's directly contracted resources with the WSMC Member's (contracted or cooperative membership) **Primary Response Contractor/Oil Spill Removal Organization (PRC/OSRO)** resources to meet WA State contingency plan requirements.

Marine Spill Response Corporation (MSRC) has contracts with the above listed 12 major deep draft P & I Clubs that provide pollution insurance coverage to these vessels. 	 WSMC will check the member's vessel OSRO coverage via USCG and P & I websites to confirm coverage before each transit. WSMC may also confirm such coverage with the Vessels Qualified Individual (QI) listed in the vessels WSMC Schedule of Vessel Information and the vessel's Federal Response Plan. If the covered vessel's P & I OSRO coverage is current and meets the supplemental OSRO requirement for the WSMC contingency plan, there will be no further action required for the WSMC Member. All vessels enrolling with WSMC under this section must have taken the steps to be bound by the Terms and Conditions of the Service Agreement with their contracted PRC and must be eligible to cite such resources in a Contingency Plan. Call-out of these PRC resources will be by the vessel's QI (in coordination with their P & I Club). Note: An agreement with the vessel's Qualified Individual (QI) will be required in association with the P & I coverage. WSMC will acquire the appropriate agreements with vessel QI's in order to complete the vessel coverage documentation requirements and the WSMC Plan.
